Back in 2018, the team at OKIE811 began working to transition our Damage Prevention and Ticket Processing Services to the cloud and to virtual offerings. We already had most of our data and operations transitioned to Azure Cloud and we were already offering virtual/webinar excavator education workshops before things got crazy in March of 2020. We also had almost half of our team members working from home. So, when 2020 hit, making the transitions needed to keep our team safe were seamless.

When we were faced with moving our statewide Excavation Safety Expo to virtual, we ended up reaching 60% more people than if we had the event in person. Our focus turned to ensuring we were here to provide quality service delivery without interruption. We collaborated with locate service providers and member companies to provide timely communications to the excavator community and we ended 2020 processing almost 970,000 locate requests and over 6,080,000 outbound notices to underground facility operators.

So, we welcome 2021 with the new challenges it brings and are committed to continue our endeavor towards excavation safety and protection of vital services provided by our members. I personally thank you for your partnership in damage prevention in Oklahoma.

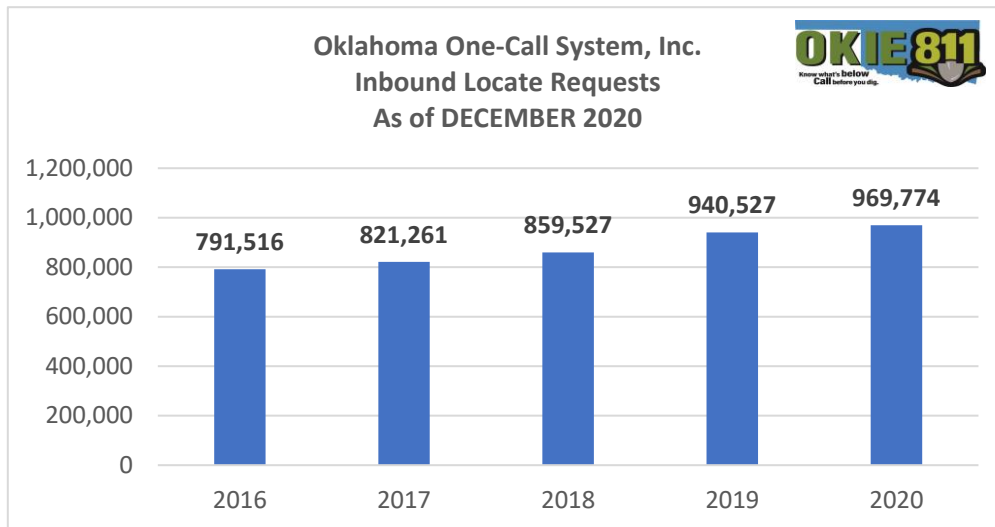

OKIE811 OPERATIONS

Overall, we ended 2020 with a **3.1% increase in ticket volume**. Every month was a record month except for July, August, and October. We also had four 5,000+ ticket days across May thru July. The interesting trend we saw throughout the year was the decrease in average number of outbound notices which has dropped over the past two years from 6.40 notifications to 6.27.



In November of 2020, we had new legislation enacted under SB-1225 which requires the type and the extent of the work, not to exceed five hundred (500) linear feet in incorporated areas or one linear mile in unincorporated areas. With this new legislation, we have seen an increase of about 5% in ticket volume in November and December due to having to break large scope work across multiple tickets.

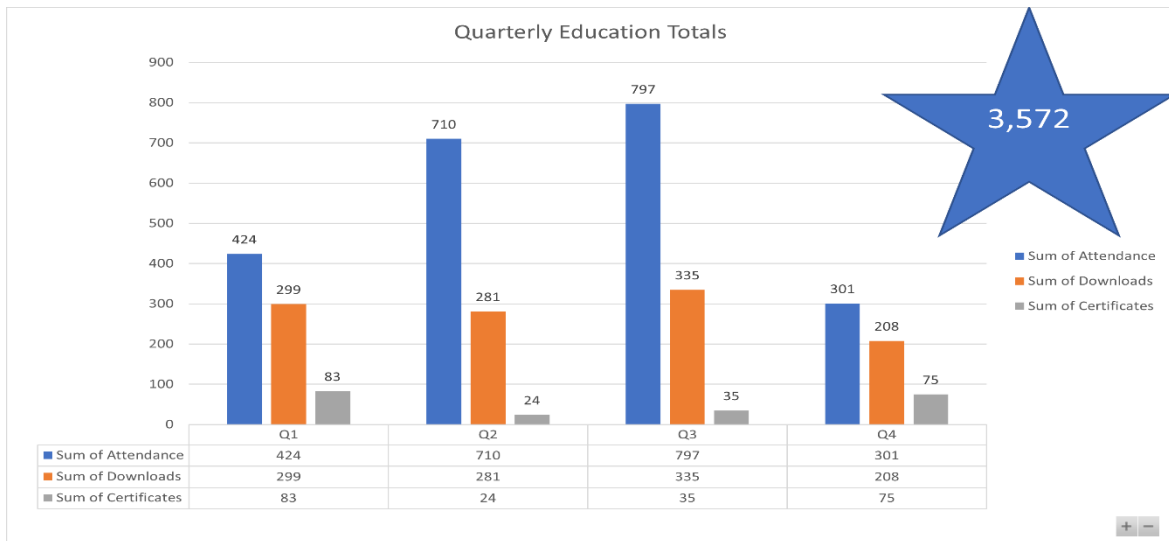
We also had many key accomplishments in 2020 that that enabled us to keep up with industry demand while going through a hiring freeze and working to keep people safe:

- OKIE811 was the leader in COVID-19 response and helped guide other states as they worked to respond.
- Automated and streamlining more of our ticket management processes including training more excavators to directly enter their own tickets and auto upgrading tickets where we had a direct parcel hit.
- Pivoted to virtual excavator education across all spectrums and had a record turnout at our annual Excavation Safety Expo.
- 100% voluntary employee retention.
- Our building mortgage got paid off.
- Able to add additional funds to our investment account (i.e., reserve account).
- Ended the year with a 3.1% increase in inbound ticket volume.

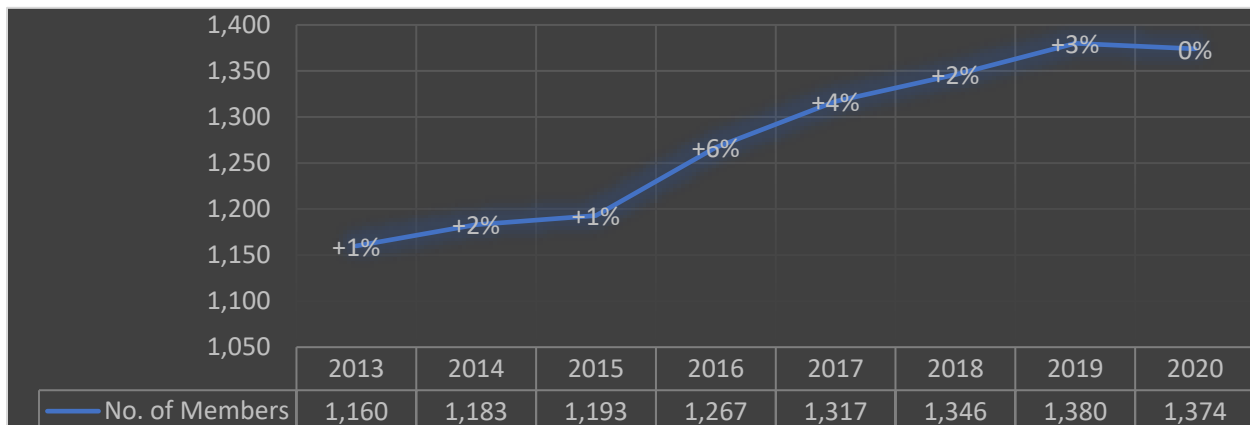
As a part of our mission to provide quality damage prevention services, we place a strong focus on the quality of the ticket (i.e., the accuracy of the information, the correct area marked, etc.). Our Quality Assurance team audits a large percentage of the tickets that are submitted by our Contact Center Reps and by the Direct Entry Excavators. We are excited to report that 99% of the tickets that are processed by OKIE811 are “safe tickets” and 97.5% submitted by direct entry excavators are “safe tickets”.

OKIE811 EDUCATION & OUTREACH

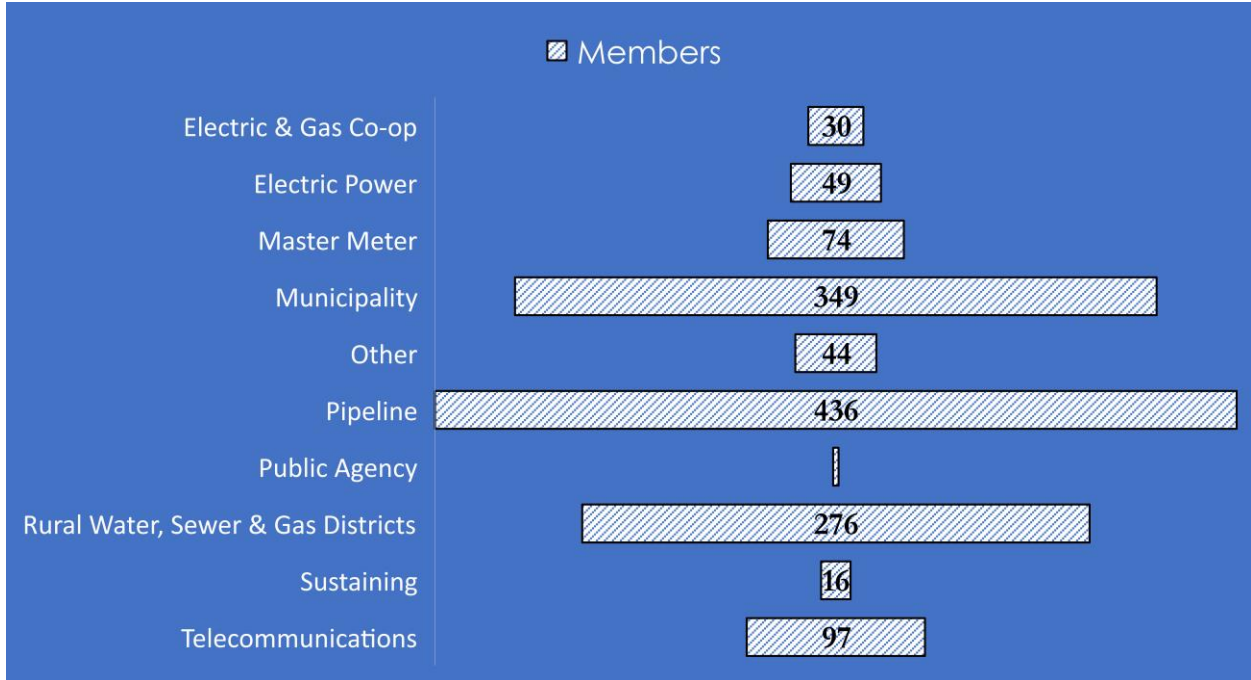
